- D1 Sample required dilution due to matrix. The limit of quantitation and the sample results were adjusted to reflect sample dilution.
- L1 The associated blank spike recovery was above acceptance limits but the samples results were less than the maximal allowable concentrations or less then limit of quantitation.
- M1 Matrix spike recovery was high; the associated blank spike recovery was acceptable.
- M2 Matrix spike recovery was low; the associated blank spike recovery was acceptable.
- R1 LFB/LFBD RPD exceeded the acceptance limits, but the recovery was acceptable.
- V1 CCV recovery was above the acceptance limits. This target analyte was not detected above the maximal allowable concentrations or less then the limit of quantitation.
